AMENDMENT TO THE REGULATION OF MINISTER OF AGRICULTURE
NUMBER 37/Kpts/HK.060/1/2006 ON TECHNICAL REQUIREMENTS AND
MEASURES OF PLANT QUARANTINE FOR IMPORTATION OF FRESH FRUITS
AND / OR FRUITY VEGETABLES INTO THE TERRITORY OF
THE REPUBLIC OF INDONESIA

THE MINISTER OF AGRICULTURE,

- Considering :
- a. that under the Regulation of Minister of Agriculture No. 37/Kpts/HK.060/1/2006 on Technical Requirements and Measures of Plant Quarantine For Importation of Fresh Fruits and / or Fruity Vegetables, the provisions regarding entry points for fresh fruits and/or fruity vegetables into the territory of the Republic of Indonesia have been defined;
 - b. that in order to reduce the risk of entry and spread of pest organisms of the quarantined plants, it is necessary to redefine the entry points for fresh fruits and / or fruity vegetables into

the territory of the Republic of
Indonesia;

c. that based on the considerations of
letter a and letter b above, it is
necessary to amend the Regulation of
Minister of Agriculture Number
37/Kpts/HK.060/1/2006;

HAS DECIDED :

To lay down : THE REGULATION OF MINISTER OF AGRICULTURE
CONCERNING AMENDMENT TO THE REGULATION OF
MINISTER OF AGRICULTURE NUMBER 37/Kpts/HK.
060/1/2006 ON TECHNICAL REQUIREMENTS AND
MEASURES OF PLANT QUARANTINE FOR IMPORTATION
OF FRESH FRUITS AND / OR FRUITY VEGETABLES

INTO THE TERRITORY OF THE REPUBLIC OF
INDONESIA

Article 1

Several provisions in the Regulation of Minister of Agriculture No. 37/Kpts/HK.060/1/2006 on Technical Requirements and Measures of Plant Quarantine For Importation of Fresh Fruits and / or Fruity Vegetables Into The Territory of The Republic of Indonesia shall be amended as follows:

1. Provision of Article 17 shall be amended to be red as follows:

Article 17

Entry Points for fresh fruits and / or fruity vegetables as referred to in Article 4, letter b, shall consist of:

- a. Tanjung Perak Sea Port, Surabaya;
 - b. Belawan Sea Port, Medan;
 - c. Soekarno-Hatta Airport, Jakarta, and
 - d. Makassar Sea Port.
2. Other provisions in the Regulation of Minister of Agriculture No. 37/Kpts/HK.060/1/ 2006 On Technical Requirements and Measures of Plant Quarantine For Importation of Fresh Fruits and / or Fruity Vegetables Into The Territory of The Republic of Indonesia shall be declared to still remain valid (hold good).

Article 2

This Ministerial Regulation shall come into force after 3 (three) months commencing on its promulgation date.

In order that everyone knows it, this Regulation of Minister of Agriculture shall be promulgated by placing it in the State Gazette of the Republic of Indonesia.
